Responsiveness:	<ol style="list-style-type: none"> 1) Duly Notarized Power of Attorney authorizing the signatory of the Service Provider to submit the bid, 2) Submission of Bid on prescribed Bid's Submission Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder, 3) Submission of Price Schedule on prescribed Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder, 4) Conformation/Compliance with Delivery Period, 5) Conformation/Compliance with Bid Validity Period, 6) Conformation/Compliance with Payment Schedule specified in the Special Conditions of Contract, 7) Registration with Income & Sales Tax Departments and proof of an Active Taxpayer of both kind of taxes, 8) Submission of required Bid Security as mentioned at ITSP Clauses 17 & 18 and corresponding details in Bid Data Sheet 9) The bidder must not have been defaulted in either honoring his bid and/ or completion of contract to AIOU, resulting the forfeiture of his either bid security and/ or Performance Guarantee, and 10) Affidavit on judicial paper of at least Pak. 
