9	Criteria for Bid Evaluation & Details of Bids Evaluation	At first, the technical bids were opened and evaluated as per pre-defined criteria in line with the published RFP. Out of four (04) bids, one (01) bid was screened out in “Responsiveness Test/Initial Screening” and the technical evaluation of the remaining three (03) bids was conducted, out of which one (01) bidder was technically disqualified for not being able to attain the qualifying marks as per the published RFP; whereas, two (02) bidders were declared Technically Qualified (after conducting Technical Evaluation as per criteria mentioned in published RFP) for next step of financial bid opening. Afterwards, financial bids of technically qualified bidders; were opened and evaluated as per the financial evaluation criteria in line with the published RFP. Finally, the Purchase Committee recommends the award of the contract on the basis of published criteria, and in line with PPRA Rules, as per following detail:
