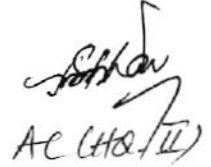

BID EVALUATION REPORT

Tender No TS374882E was uploaded on PPRA website on 14.12.2018 with closing date of 08.01.2019 as per PPRA Rules, 2004 for supply of uniform and livery items for the Class-IV Employees in MCC (Preventive), Custom House, Karachi. In response, thereto three bidders, M/s I.S Enterprises, Hassan Enterprises, Waqas Enterprises and Malik Enterprises took the tender forms to participate in bidding. On the closing date i.e 19.06.2018 till 15:00 hours only three bidders namely M/s I.S Enterprises, Hassan Enterprises and Waqas Enterprises submitted the sealed bids alongwith their documents.

The sealed Tenders consisting of single envelope, were opened on the same day at 1430 hours in the chamber of Chairman Purchase Committee Mr. Muhammad Aamir Thahim, Additional Collector of Customs Headquarters, MCC Preventive, Custom House, Karachi in the presence of the members of Purchase Committee as mentioned below and the representatives of bidders;

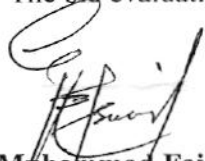
M/s. Waqas Enterprises

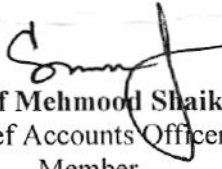
As per documents submitted by M/s. Waqas Enterprises show that they are registered with the Income Tax & Sales Tax departments. Summit Bank Pay Order No. 00033221 dated 07.01.2019 of 2% bid amount value Rs.36000/- in favour of Collector of Customs is also attached instead of Pay Oder as required with the tender documents. They have quoted bid amount of Rs. 283200/- 283200/- 79800/- 93988/- 599400/- and 46500/- for item number 1-6 respectively (Inclusive of all taxes) for all the items which comes to total bid amounting to Rs. 1,386,088/- (Inclusive of all taxes).

Conclusion

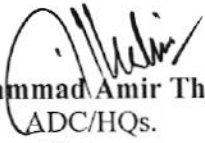
Scrutiny of the documents reveals that all three bidders M/s I.S Enterprises, Hassan Enterprises and Waqas Enterprises, have submitted their prices for the supply of requisite items and on the basis of lowest price, the Purchase Committee decided with consensus to award the contract to **M/s. I.S. Enterprises** to the extent of item No. 1, 2, 3, 4 & 6 excluding item No. 5 i.e. Black leather shoes due to low quality of this item, however, all rest of products have almost same quality of products vis-à-vis other bidders.
