

The Purchase Committee of the department, is also assisting the purchases made under development projects. After the expiry of given time i.e. 12.00 a.m., the committee opened the sealed tenders/quotations on the same day i.e. 31-03-2022 in the presence of the bidders/representatives. Single Stage- two envelope bid evaluation method was followed;</p> <ul style="list-style-type: none"> - Technical proposal of the ten (10) firms were opened on 31-03-2022 for technical evaluation for category 1: Lab equipment. Technical evaluation of the proposal of all the ten (10) firms were done keeping in view the specification required. The firms which did not meet the technical specification, their proposals were rejected on technical grounds. - The Companies that qualified technically were communicated the technical evaluation outcome and financial evaluation of category 1 was done on 12-04-2022. Evaluation of technical proposals revealed following outcomes; <ul style="list-style-type: none"> • M/s Rays Technology applied for seventeen (17) items, specification for sixteen (16) items were as per requisite aspect, and proposal for pH meter was rejected. • M/s Technology International applied for two (02) items, two items (02) which met the technical criteria, all items were accepted for financial evaluation. • M/s Diagnostic Systems applied for four (04) items, proposal for water bath met the technical criteria, however three (03) items rejected on technical ground. • M/s Leo Science applied for Multi-Scan GO, which met the requisite technical criteria. • M/s Chemical House applied for two (02) items, two items (02) met the technical criteria, and all items were accepted for financial evaluation. • M/s InfoTech applied for five (05) items, three (03) items met the technical criteria, and proposal for water deionizer unit and Gel Electro-phoresis apparatus were rejected on technical ground. • M/s Elite Traders applied for nine (09) items, five (05) items met the technical criteria, and however four (04) items were rejected on technical ground. • M/s Multi LinkX applied for twenty seven (27) items, twenty six (26) items which met the technical criteria, proposal for Micro-Pipette (02-20ul) was rejected on technical ground. • M/s WorldWide Scientific applied for twenty four (24) items, which met the technical criteria, all items were accepted for financial evaluation.



Firms providing required specification and offering lowest rates were accepted. • For category 3. Furniture and Fixtures, Only two (02) firms participated i.e. M/s Margalla Enterprises & M/s Tradelink International participated. Samples for furniture were provided by two firms on dated: 09-03-2022. <p>2. The Purchase Committee as per detailed analysis of the specifications and rates offered for item 01 of category 2 recommended to Tradelink International and items 2, 3, 4, 5 of category 2 recommended to Margalla Traders. 
