- A. Same Price is offered by M/s Capital Engineering Services Islamabad and M/s Jawad Enterprises Multan for Item (Hard Disk 4-TB) at Sr. No.29, however, M/s Capital Engineering Services Islamabad is approved as most advantageous bidder on the basis of more Pre-qualification marks (40) as compare to M/s Jawad Enterprises Multan (34), obtained in Prequalification Process.
- B. Single financial bid qualifies for Sr. No.22, 23 and 25; hence single non-competitive bids for these items are not approved and these items may be procured on as & when required basis as per PPRA Rules.
- C. Tax calculations (with GST) errors have been corrected by considering the price of items without GST from all bidders as per ITB 31.1 of Bidding Documents. Additional spreadsheets detailing line-item comparisons of bids with GST & without GST of all bidders is attached as Annex-A to Evaluation Report and correct price with GST has been calculated.
- D. Bids of Items at Sr. No. 19 (Electric Cable 7/44: Three Core) & Sr. No.20 (Electric Cable 7/52: Four Core) from M/s Capital Engineering Services Islamabad was rejected being incorrect (bidder also accepted the same) and second most advantageous bids of said items have been approved.
