2. With the approval of Competent Authority, tender for purchase of Miscellaneous Consumable Items through E-PADS pertaining to M-4 Sector-I, Toba Tek Singh and sub-sector M-4, Khanewal for the financial year 2023-24 was floated on NHMP & PPRA website on 28-03-2024 respectively.

3. Meeting of the Sector Purchase Committee M-4 Sector-1, Toba Tek Singh was held for opening of Financial Bids on 25-04-2024 at 1130 hrs on account of financial evaluation of qualified firms for purchase of Miscellaneous Consumable Items for the financial year 2023-24.

4. Three (03) firms were technically qualified in the tender for purchase of Miscellaneous Consumable Items. All firms submitted their bids through E-PADS.

5. Purchase Committee of Motorway M-4, opened the financial proposal of qualified firms to evaluate the most advantageous bidder in the light of prevailing government instructions (as mentioned in Standard Bidding Documents). Firm wise detail /financial evaluation is as under:-

- **M/s New Asif Traders, Toba Tek Singh** for four (04) miscellaneous consumable items being lowest / most advantageous bidder for total amount **Rs. 351,760/-** (Rupees three lac fifty one thousand seven hundred and sixty only).
- **M/s Malik Enterprises, Toba Tek Singh** for supply of ten (10) miscellaneous consumable items as mentioned in Financial Evaluation Report (enclosed) for amounting **Rs. 637,819/-** (Rupees six lac thirty seven thousand eight hundred and nineteen only).

7. 
