INTRODUCTION

1. The Due to the recent development of handing over of Berth Nos. 10-17 to AD Port for operations, it has become necessary to shift the railway material belonging to KPT lying in the area to a safe place at West Wharf, as the area of East Wharf is soon going to be handed over to AD Port.
2. Hence, AXEN (PW) was directed to take necessary measures and arrange for shifting of the KPT railway material from East to West Wharf at the designated place as identified by Manager (Stores) for Auction of material as per their schedule.
3. AXEN (PW), after a survey, has prepared an Estimate amounting to Rs.996,660.00 (inclusive of 13% SRB Tax) placed at S.No.1, for attending the subject work through outsourcing, as the same is beyond the scope of In-house arrangements.
4. According to Rule-36(a) of PPRA tenders for the work were invited through KPT / PPRA & MoMA Website and received on 20-02-2024.
