China.	<p>Price Bid was not opened as the bidder was Technically non-responsive due to the following reasons: Three of the participating bidders i.e. M/s China Energy Engineering Group Jiangsu Power Design Institute (M/s JSPDI), M/s China Energy Engineering Group Gansu Electric Power Design Institute Co, Ltd (M/s GSEPDI) & M/s Central Southern China Electric Power Design Institute Co Ltd (member of CNI22-CSEPDI Joint venture) belong to the same group i.e. M/s China Energy Engineering Group Corporation Ltd (M/s CEEC). <i>This constitutes a conflict of interest as per ITB clause 4.3 of the bidding document which prohibits the bidders from having controlling shareholders in common or from having any relationship with each other directly or through common third party.</i> Thus M/s JSPDI, GSEPDI & CNI22-CSEPDI JV are considered disqualified due to conflict of interest as per ITB 4.3 of Section I of the bidding documents.</p>
