		firms namely M/s Intime solutions Ibd, M/s R.K. Traders, Ibd, M/s Fast Tracks Ibd, M/s Nafees Kazim Associates Ibd and M/s Akbar & Co Ibd submitted the complete bid, While M/s Sultan Furniture, Rwp, M/s All Rounder Rwp and M/s Eurotec Ibd submitted not only less Earnest money as per terms of condition but also incomplete items for Bid. The Purchase Committee as per tender terms and condition does not recommend these firms bid. As per detail analysis of the rates offered by the (05) firms the major items offered by the M/s R.K. Traders were lowest as compared with the other four bidders. The Purchase Committee further recommended that vendor who has qualified the bid shall supply the items as per requirements, quality and in stipulated time. Delay in supply of item shall be reported in the PPRA and further necessary action as envisaged in the PPRA rules shall be exercised.
