MINUTES OF THE MEETING OF THE DEPARTMENTAL TENDER COMMITTEE HELD ON 02-02-2024 IN THE OFFICE OF CHIEF ENGINEER, ENGINEERING DEPARTMENT, K.P.T.

NAME OF WORK:RE-HABILITATION OF FIRE FIGHTING NETWORK AT WEST WHARF AREA KPT.

INTRODUCTION:

- 1. A Periodic testing of Fire Hydrants at various places of West Wharf have been carried out jointly by the Engineering Department & Port Fire Department.
- 2. Further, it is pertinent to mention here that during the said testing, it has been observed that, 203 Nos. Fire Hydrants Chambers and fitting / fixtures were found damaged and non-operational, which are required to be fixed by immediately, in-order to keep the Fire Hydrant System operational in the Port area. Further, some of the Fire Hydrants also need replacement of valves, spindles and other related works.
- 3. The Detail status of the Fire Hydrants is mentioned as below & at F/A. Photographs of the same are also placed at S.No.04.

Accordingly, a detailed survey was carried out by AXEN (W/S) of the entire Fire Hydrant Network in West Wharf alongwith staff of Port Fire Department and PFO on 02-10-2023 and has prepared an Estimate amounting to Rs.7,120,186.50 (inclusive of 13% SRB Tax) alongwith a Plan placed at S.No.5 & 5/A respectively, for attending the subject work through outsourcing, as the same is beyond the scope of In-house arrangements.
- 5. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through Press, KPT / PPRA & MoMA on Website 20-12-2023 and received on 08-01-2024.

SAK Contractor which is 05.04% above the corresponding estimated cost of Rs.7,120,186.50 based on current market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-5 (m) M/s. SAK Contractor is considered capable for carrying out this work.
