INTRODUCTION:

1. Manager (IR&W) vide his letters placed at S.No.1 has informed that Dining Hall adjacent to Café, KPT may be used as Female Canteen in order to provided a personal & separate space for female staff of KPT. However, in this regard some repair / maintenance works are required in order to convert it into a proper canteen. Accordingly, AXEN (MIY) have prepared necessary Estimate amounting to Rs. 928,852.00 alongwith a Plan placed at S .No. 2 (A) & 2(B) respectively, the work will be attended through outsourcing as the same is beyond the scope of In-house arrangements. The cost of work is Rs. 358/- per Sq.ft excluding contingencies & 13% SRB.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 20-03-2024.




