3. The Technical and Tender Purchase Committee evaluated the financial bids of both qualified firms on the basis of earnest money in shape of CDR (i.e. 2% of Total Bid amount) and rates quoted by the firms. Committee announced the rates offered by each firm. The evaluation results are as under: -
