The Qualification Requirements in terms of Eligibility &amp; Responsiveness is observed as follows in terms of ITB 12.2(a) as mentioned in Bid Data sheet:-</p> <ol style="list-style-type: none"> <li>a. Bidder(s) shall provide National Tax No. and Sales Tax No. The bidder shall also provide evidence of being on the Active Taxpayers List (ATL) of FBR.</li> <li>b. The bidder must have successfully completed at-least three (03) relevant contracts during last five (05) years.</li> <li>c. Combined turnover of last two years shall not be less than PKR 2.5 million (PKR 2,500,000.00).(Documentary evidence must be required i.e. purchase order / work order / supply order / contracts etc as proof for evaluation).</li> <li>d. Bidder(s) must provide the leaflets/ brochures/ catalogs of quoted product with the bid.</li> <li>e. The bid and price schedule should be submitted on the prescribed format on company's letterhead. Both must be signed and stamped by the authorized person.</li> <li>f. Bid Security as mentioned at ITB clause 13.1 must be furnished from scheduled Bank of Pakistan.</li> <li>g. The bidder shall submit an affidavit on legal stamp paper of Rs. 100/-, duly named, signed and stamped by the signing authority/person competent and having the power of attorney to sign, to the effect that bidder has not been blacklisted by any of the Federal / Provincial Government Department/Organization.</li> <li>h. Bids shall remain valid for the period of 120 days as mentioned at ITB clause 14.1.</li> <li>i. The bidder must have proper Business Setup i.e. shop, outlet or office with preferably landline telephone facility.</li> </ol>

### **Technical Evaluation**

7. For technical evaluation and to check conformance of the quoted items with the required specifications given in the bidding document, the technical bids were forwarded to Procurement Evaluation Committee. On the basis of initial compliance status and technical evaluation, following criteria for Technical Evaluation was observed as per Bidding Documents **ITB 23.2** mentioned in Bid Data sheet:

- (i) Bidder may bid for one or both lots.
- (ii) Delivered Duty Paid Price only inclusive of all applicable indirect taxes (GST), duties, freight (transportation), charges, insurances & warranties, if any, etc. on Lots basis.
- (iii) The Bidder has to quote only one rate for the respective lot as per Bid's specification. No alternate model/bid shall be accepted.
- (iv) Evaluation will be done on the basis of most advantageous bid for complete requirement of each lot. Bids submitted for partial requirement for each lot shall not be considered (non-responsive). Bidder are required to bid for 100% required quantity for each lot as mentioned in the Bidding Document on Delivered Duty Paid price basis i.e. inclusive of all applicable indirect taxes (GST) & complete transportation & delivery charges, insurances & warranties etc.
- (v) The Goods must be delivered within given time as specified in Section-III Schedule of requirement.
- (vi) Alternate bids shall not be accepted.
- (vii) Compliance to the Qualification Requirement and Technical Specification as proposed in ITB 12.2 (a) and Section III of Bidding Document respectively.
- (viii) No alternate model/bid or separate accessories shall be accepted.


