Bidder(s) must provide the leaflets/ broachers/ catalogs of quoted product with the bid. e. The bid and price schedule should be submitted on the prescribed format on company's letterhead.  - (ii) The Goods must be delivered within given time as specified in Section-III Schedule of requirement.
 - (iii) Alternate bids shall not be accepted.
 - (iv) Compliance to the Qualification Requirement and Technical Specification as proposed in ITB 12.2 (a) and Section III of Bidding Document respectively.
 - (v) No alternate model/bid or separate accessories shall be accepted.
