**MINUTES OF OPENING OF TENDER REGARDING PURCHASE OF DATA CENTRE SETUP, IT EQUIPMENTS AND MISC. ITEMS FOR CMA (P) LAHORE DURING CURRENT FY 2021-22**

In pursuance of "Approval in Principle" conveyed vide MAG's Office Rawalpindi letter No.312/AN/515/2021-22/CMA (P) dated: 15-03-2022 for purchase of Data Centre Setup, IT Equipments and Misc. Items, quotations were called for through "Open Tender"(Single Stage - Two Envelope Procedure) i.e. publication of tender notice on PPRA's website on 21-03-2022 and in two national dailies one Urdu and one English i.e. Dunya and The Nation respectively on 27-03-2022. In response thereto, fourteen firms purchased tender documents however five (05) firms/bidders submitted bids upto closing date and time i.e. 11-04-2022 upto 11:00 A.M. Technical bids were opened on the same date at 11.30 A.M in the presence of Technical Evaluation Committee IT and Station Purchase Committee (constituted by the MAG) and available representatives of the bidding firms.

Upon opening of financial quotations of technically successful bidders it revealed that although technical bid of some items i.e. **12 x Laptops, 110 x Desktop Computers with LEDs, 01 x Networking with Equipment, 01 x LED TV for Conference Room/Training Room, 03 x LED TV for Security Room, 01 x Sound System, 01 x Complete Electrification for DCS Building for ACs, UPS and Networking etc, 02 x Inverter AC 1.5 Tons, 35 x Inverter AC 2 Tons and 02 x Inverter Cabinet AC 2 Tons** have been qualified but their offered prices are not rational and too much higher than estimated cost. 


