10.	Details of Bid Evaluation	<p>Thirteen Sealed tenders were received till the closing hour i.e. 11.00 am dated 29-04-2019 as mentioned in the tender documents. The Purchase Committee of the department, which is also assisting the purchases of newly created department on Plant Breeders Rights Registry (PBRR), after the expiry of given time i.e 11.30 a.m opened the sealed tenders/quotations on the same day i.e 29-04-2019 in the presence of the bidders/representatives.</p> <p>For purchase of Computer Equipment (13) firms participated in the bid held on 29-04-2019. The Purchase Committee as per tender terms and condition mentioned in para (4) scrutinized firms on the basis of authorized dealership license on quoted brands. Four (04) firms namely M/s Mehar & Sons, Ibd, M/s Time & Tune Rwp, M/s Margalla Trader Ibd and M/s Hafsa Int, Lhr submitted the dealership license with Tender.</p> <p>The Purchase Committee as per detail analysis of the rates offered by these firms, the items offered by the M/s Mehar & Sons i.e Laptop hp(14"), , LaserJet printer, fax, scanner M426FDN and Color LaserJet M254NW were recommended technically and financially having low rates with valid vendor number and service. For Desktop computer Dell, Laptop hp (15.6") and printer LaserJet M402N the purchase committee recommended M/s Margalla Trader Ibd having submitted low rates with valid vendor number and service, Similarly, for supply of UPS M/s Smartnet Ibd was recommended technically and financially having submitted low rates. The Purchase Committee further recommended that vendor who has qualified the bid shall supply the items as per requirements, quality and in stipulated time. Delay in supply of item shall be reported in the PPRA and further necessary action as envisaged in the PPRA rules shall be exercised.</p>

For Desktop computer Dell vestro, Laptop hp (15.6") and printer LaserJet M402N, the purchase committee recommended **M/s Margalla Trader Ibd** having submitted low rates. Similarly, for supply of UPS **M/s Smartnet Ibd** was recommended technically and financially having low rates by the Purchase Committee.
