INTRODUCTION

1. The jurisdiction of Kemari wharf starts from NMB / NOB Gate to coal yard including Oil Piers. The security wall is running throughout the periphery to maintain the Port Operation on round the clock basis. Due to continuous heavy vehicular movement, on & often various natures of accidents occurs. It is very common that, security wall gets damaged and fall down making Port unsafe and insecure to any incident.
2. Keeping in view to maintain the damaged Security wall a running contract is required to attend the work without any delay of inviting tenders for a particular job.
3. Being a running contract for the period of 12 months the exact location of work cannot be marked however the location of existing security wall in plan which is about 5.0 KM in length.
4. AXEN (KW) accordingly carried out a survey and on the basis of Past Experience and damaged report of wall assessed the quantum and entered in estimate for inviting tender.
5. Tenders for the work were therefore invited through KPT / PPRA Websites and received on 11-12-2020. Accordingly to under rule 36(a) of PPRA.
