 - iii) Firm that has a minimum **Average Annual Construction Turnover of Rs. 499.7 Million** based on the last three years (2019 - 20, 2018 - 19 and 2017 - 18) audit reports. **(Audit Reports are must to be provided).**
 - iv) Firm that has a minimum **Average Working Capital of Rs.187.4 Million** based on the last three years (2019 - 20, 2018 - 19 and 2017 - 18) audit reports. **(Audit Reports are must to be provided).**
 - v) Firm that has the capacity to generate minimum **Cash Flow of Rs.62.5 Million**, based on the last three years (2019 - 20, 2018 - 19 and 2017 - 18) audit reports. **(Audit Reports are must to be provided).**
 - vi) Firms with satisfactory Past or present performance with NHA or any other executing agency and that have not been blacklisted earlier by any government agency/ authority / organization.
