Evaluation Remarks

- ⇒ All items were sent to FSD Production Team for necessary testing / cooking and their final comments for evaluation committee.
- ⇒ As per the Manager of Production / Executive Chef and Sous Chef the items were tested / cooked and found accepted and rejected.
- ⇒ After thawing sample 3-4 [Al-Tayyab] found bad smell.
- ⇒ Sample 3-4 [Al-Tayyab] Boti shred during cooking.
- ⇒ While cooking Boti convert into shred [not good for final product result presentation]
- ⇒ Chicken Boti size is not as per specifications.
- ⇒ M/s. Al-Tayyab is PIA existing chicken supplier unfortunately they failed to supply required quantity on time.
- ⇒ Many time PIA Food production has collapse due to unavailability of chicken.
- ⇒ FSD Production has registered too many quality related complaints against chicken supplies.
- ⇒ It is routine to find foreign object in Al-Tayyab chicken.
