#### NAME OF WORK: MAINTENANCE / REPAIRS & ALLIED WORK OF KGCC\_GATE AND PAINTING WORK OF BOUNDARY WALLFROM BOAT BASIN TO KGCC.

#### **INTRODUCTION:**

1. During site visit of Hi-ups it has been observed that Boundary Wall opposite to Oil Piers and M.S Gate of KGCC have become in dilapidated condition as on many places cracks have been developed. The overall length of each side of both walls is 6600 Rft. with average height 08'-00 Ft. Keeping in view to maintain the structure and VIP movement on this area, it was therefore decided to attend subject work.

Accordingly, AXEN (KW) after survey of site have prepared an Estimate amounting to Rs.990,608.85 alongwith plan placed at S.No. 2(a) & 2(b) respectively, for attending the works through outsourcing, as the work is beyond the scope of In-house arrangements.

2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through KPT, MoMA & PPRA Website and received on 08-04-2024.
