**B) Detailed Technical Evaluation**

The eligible bids were evaluated under detailed Technical Evaluation for following aspects based on PEC Standard / Guide lines.

- a. Experiences
  - Average Annual Turnover of the last three years construction turnover (Marks Allocated 20).
  - Firms Experience of similar contracts completed during last ten years (Marks Allocated 20).
- b. Personnel proposed for the project (Marks Allocated 10).
- c. Equipment proposed for the project (Marks Allocated 10)
- d. Financial Soundness (Marks Allocated 35).
- e. Litigation (Marks Allocated 5)



The total sum of above categories / sub categories is 100 Marks. It is mandatory for bidders to obtain 75marks out of said total on aggregate to qualify and obtain 50% marks to get qualified in each category.

For Technical Qualification Scoring System is adopted.
