2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 18-04-2024.

Suntech International which is 10.97% above the corresponding estimated cost of Rs.817,379.85 based on KPT revised schedule of rates 2023-24 is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. Suntech International is considered capable for carrying out the work viz. **“RENOVATION OF CHAIRMAN’S OFFICE WASHROOM AT KPT HEAD OFFICE”**.
