***As per published bidding document, arithmetic error occurred in terms of calculating 300 instead of 150; however, procuring agency in advertisement required 150 but in bidding document it was asked for provision of two washbasin in each school of FDE and it is presumed by bidders 300 quantities instead of 150. This occurred due to the 2-wash basin in each school written in Bidding document however, some bidders given the quantities 300, some bidders given quantities 150 washbasin, As per PPRA rules the unit rate will prevail for each wash basin as per prevailing modification clause provision procuring agency can increase/decrease of quantities as per the clause 3 of the bidding documents. However, in th advertisement 150 Washbasins were demanded as budget for 300 is not approved from World Bank and Procuring Agency. Committee sheet Annexed.


