


# FINAL EVALUATION REPORT

Particulars	Remarks
i- Office Table (Wooden) 444 Nos.	Total five firms namely, M/s Mahmood Furniture House, M/s Akbar & Co. M/s Lodhi Traders, M/s Fine Wood Works and M/s Master Wood & Steel Centre participated in technical evaluation, which were opened on 08.06.2022 at 11.30 a.m. Upon Scrutiny of technical proposals, it was transpired that M/s Mahmood Furniture House quoted price/ CDR mentioned on Technical proposal as well as delivery time was not mentioned in Technical Proposal. Moreover Quoted specification of Office Table Wooden did not match with the specification of tender.
ii. Official Chair 444 Nos.	The Technical Proposal of M/s Akbar & Co. does not carry warranty documents as well as delivery time mentioned in the proposal was 60 days which was rejected by the Tender Committee.
iii- Visiting chair 296 Nos.	Upon detailed examination of the technical proposal of M/s Lodhi Traders, it was unearthed that warranty documents were not attached. The firm also submitted outdated stamp papers which were issued in favor of Department of irrigation Tubewell. Beside this the Firm does not fulfill relevant experience and clause of 10 Million Turnover for last Two Years. The firm also attached CDR with technical proposal which was caused of rejection by the tender committee unanimously.
iv- Almirah (Steel) 148 Nos.	Out of Five, two Firms namely M/s Fine Wood Works & M/s Master Wood & Steel Centre were technically qualified whose financial bids were opened on 09.06.2022 in presence of firms wherein M/s Fine Wood Works Quoted lowest rate i.e Office Table (Wooden) @ Rs. 18,018/-, Official Chair @ Rs. 15,678/-, Visitor Chair @ Rs. 6,891/-, and Almirah (Steel) @ Rs. 26,793/- . Tender Committee Unanimously Decided to award the Tender to <b>M/s Fine Wood Works</b> . However Highest i.e M/s Master Wood & Steel Centre quoted rates Office Table (Wooden) @ Rs. 19,773/-, Official Chair @ Rs. 16,614/-, Visitor Chair @ Rs.10,280/-, and Almirah (Steel) @ Rs. 34,398/-
