Ltd have fulfilled the qualification and experience required for technical evaluation and were technically responsive, therefore were accepted for opening of their financial bids. The remaining four firms lacking the requisite qualification and experience for technical evaluation and being technically non responsive were rejected and their financial proposal were returned un opened. The tender was awarded to M/s Khyber Impex Pakistan Pvt. Ltd being the lowest financial bidder and within the budget provision.
