#### MINUTES OF THE MEETING OF THE DEPARTMENTAL TENDER COMMITTEE HELD ON 27-05-2024 IN THE COMMITTEE ROOM OF THE ENGINEERING DEPARTMENT, KPT.

#### NAME OF WORK:<u>RE-HABILITATION OF RAIL TRACKS AT GATE NO. 36 & VARIOUS</u> LOCATIONS AT WEST WHARF.

- The Rail Tracks in West Wharf were laid by KPT in early 1960s, and same are under the use of Pakistan Railways for embarkation / disembarkation of cargo to and from KPT. The entrances of the Rail Tracks are at the Gate No. 36 where, 03 Nos. tracks are present for the movement of the Pakistan Railways Locomotives.
- 2. The routine maintenance of the tracks is being done by KPT Permanent Way Sub-Division. However, with the passage of time the tracks have become dilapidated, due to wear / tear and extensive use of the same.

It is pertinent to mention here that, these tracks have outlived their useful life and are in deteriorated condition & have sinked at some locations, causing a lot of time to time derailments, which results in un-necessary delay of train movement as observed by this Department & informed by the Pakistan Railways Authorities.

- It is pertinent to mention here that, the Rail Track at Gate No. 36 West Wharf, is the only Entrance Point for the Railway Wagons & is the main artery for the Import & Export of cargo movements via Railway Wagons.
- 4. It would not be out of place to mention here that, several incidents of derailment of Railway Wagons have occurred in the past few months & the same have caused severe damages to the tracks as well as to Railway Wagons. Hence, it is deemed necessary that the tracks at Gate No. 36 be re-habilitated.
- 5. Accordingly, the Dy. Chief Engineer-I alongwith the Executive Engineer & Asstt. Executive Engineer (PW) of KPT visited the site, wherein it was observed that, some of the Tracks needs immediate repair / rehabilitation work which is includes, the Rail Track length of approximately 130 T/Mtr. and the area of flush track which is to be re-carpeted is about 6,000 Sq. mtr.
- 6. It is pertinent to mention here that, several complaints from the Pakistan Railways Authorities have made the work of rehabilitation of Rail Tracks undeniable. (copies of the same for ref. are placed at F/A)
- Accordingly, AXEN (PW) has prepared an Estimate amounting to Rs.46,196,378.00 alongwith a Plan placed at S.No.1/A & 1/B respectively, for attending the work through outsourcing, as the same is beyond the scope of In-house arrangements.

The Estimate is based on current market rates including 13% SRB.

- Hence, the tenders were invited through Press, KPT / PPRA & MoMA Websites on 14-03-2024 in accordance to the Rule 36 (b) of PPRA and received on 07-05-2024.
- 9. In response, the following Two (02) Firms submitted their sealed Technical & Financial Proposals.

  - e. Copy of Valid PEC Registration Certificate.
  - f. Affidavit, that the firm is not defaulter in Income tax department nor blacklisted by any Organization.
  - g. Provision of Audited financial statement for last seven years showing minimum turnover of Rs.20 (Million) on average.
  - h. Relevant work experience i.e. Road Works worth not less than 10.0 (M) for at least one Project in last 10 Years.
  - i. All submission will be duly signed & stamped by the Bidder.
- 13 After due diligence, the Committee submitted its detailed Technical Evaluation Report (placed at S.No.32 for reference).
- 14 As per the Technical Evaluation Report of In-house Committee, out of Two bidders, only One (01) bidder M/s. Al-Madad Construction Co. stood Technically Qualified.

"<u>RE-HABILITATION OF RAIL TRACKS AT GATE NO. 36 & VARIOUS LOCATIONS AT WEST</u> <u>WHARF</u>" and return of un-opened Financial Bid of Non-qualified Bidder i.e. M/s. Valiant Corporation.
