



Evaluation Criteria

- i. Bidder(s) must have at-least three (03) years of experience of similar nature as requisitioned in the bid.
- ii. Bidder(s) must provide copies of supply orders to establish the required experience.
- iii. Bidder(s) must provide complete List of Clients including details of at least 2 current clients along with their contact information.
- iv. Bidder(s) shall have National Tax No. and Sales Tax No. The bidder should be on Active Taxpayers List (ATL) of FBR.
- v. Bidder(s) must submit Manufacturer's Authorization on the format provided in Section IV of the bidding documents with his bid w.r.t to LOTS 1 to 5.
- vi. Bidder(s) must provide the leaflets/ brochures / catalogues of quoted products with the bid.
- vii. The bid and price schedule should be submitted on the prescribed format on company's letterhead. Both must be properly signed and stamped by the authorized person.
- viii. Earnest Money as mentioned at following ITB clause 13.1 must be furnished from scheduled Bank of Pakistan.
- ix. Bidders must provide an Affidavit on judicial stamp paper of Rs. 100/- that bidder is not blacklisted by any Public Sector Organization.
- x. Bids shall remain valid for the period of 120 days as mentioned at ITB clause 14.1

ii. LOT # 2

For LOT-2, there was a single responsive bidder i.e. M/s Margalla Traders. The Committee observed that although the bid of M/s Margalla Traders for LOT # 2 is responsive, however, M/s Margalla Traders was



the single responsive bidder for this Lot. In the light of PPRA Guidelines, the Committee recommended that an independent Committee may be constituted to check the reasonability of the price of Rs. 4,995,000/- quoted by the single complying bidder for LOT # 2.


