

<b>Responsiveness:</b>	<ol style="list-style-type: none"> <li>1) Duly Notarized Power of Attorney authorizing the signatory of the Service Provider to submit the bid,</li> <li>2) Submission of Bid on prescribed Bid's Submission Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder (Bids submitted otherwise, shall not be accepted),</li> <li>3) Submission of Price Schedule on prescribed Form, as per the format provided in the bidding document, printed on letterhead of the bidder, and duly signed and stamped by the authorized representative of the bidder (Bids submitted otherwise, shall not be accepted),</li> <li>4) Confirmation/Compliance with Delivery Period,</li> <li>5) Confirmation/Compliance with Bid Validity Period,</li> <li>6) Confirmation/Compliance with Payment Schedule specified in the Special Conditions of Contract (deviations in payment schedule shall not be accepted),</li> <li>7) Registration with Income &amp; Sales Tax Departments and proof of an Active Taxpayer of both kind of taxes,</li> <li>8) Copies of last One (01) year's Annual GST &amp; Income Tax Returns.</li> <li>9) Submission of required Bid Security as mentioned at ITB 17 &amp; 18 and corresponding details in Bid Data Sheet, and</li> <li>10) Affidavit on judicial paper of at least Pak. <b>Qualification:</b>	<ol style="list-style-type: none"> <li>1) Through the last one (01) year's Annual General Sales Tax and Income Tax Returns, as a minimum, the Bidder's net worth for the said period should be at least equal the total value of bid,</li> <li>2) Successful completion of at-least three (03) contracts having nature, and complexity similar to the scope of requirements described under the Bidding Document, during last five (05) years,</li> <li>3) Samples of Paper should be meeting the required criteria/ specifications. The Procuring Agency shall execute the test of the provided samples at its own Laboratory and the bids of the only those bidders shall be considered whose sample(s) shall technically passed by the University's Laboratory. The Laboratory Report shall be unchallengeable, and</li> <li>4) Warranty Coverage Details.</li> </ol>		


