In the light of PPRA Guidelines, the Committee recommended that, an independent Committee may check the reasonability of the price quoted by the single bidder for Lot 2 & 3. Evaluation results for lots 2&3 will be declared after completing the necessary proceedings of Price reasonability Committee.
