Kindly refer to the subject captioned above.

2. It is stated that in the light of the approval of the competent authority, communicated vide DD RSF NHMP, Islamabad office letter No. NHMP-RSF/2022-23/1579 dated 20-03-2023, an advertisement for invitation of tender for procurement of Machinery & Equipments from interested well-reputed GST registered firms for procurement of different machinery & equipments for this sector was placed/uploaded at NHM, PPRA and national newspapers. The detailed specifications were given in tender documents, provided to interested bidders and existing sample were shown to suppliers. The required quantity of items is as under:-

- In order to facilitate, monitor and supervise the whole tender process "Technical", "Purchase" and "Inspection" committees were constituted vide officer order No. NHMP/DIG/MC-II/Log/2023 dated 26-01-2023.
- 4. On 05-07-2023, the sealed offers / bids were received from (03) firms directly and 02 firms through couriers at Zonal Office Motorway Central-II, Multan by the purchase committee members until 1100 hrs and the same were opened on the same day at 1130 hrs. The meeting was chaired by DIG / Zonal Commander Motorway Central-II Zone, Multan (Chairman Purchase Committee) and purchase committee members as well as following representative of the bidding firms attended the meeting.
  - M/s Hashmi Trading & Company, Multan Representative
  - M/s Office Automation Group Lahore Representative
  - M/s Chaudhary Enterprises Lahore Representative
  - M/s Adan Enterprises, Nowshera Sent through courier
  - M/s Malik Enterprises, Toba Tek Singh Sent through courier

The meeting started with the recitation of the Holy Quran. The chair thanked all the participating firms and emphasized the importance of fairness and transparency in the department's operations. The chair also assured full cooperation to all participating firms. However, the chair has expressed the desire for the same transparency and honesty from all firms doing business with NHMP. The offers/bids submitted by the following firms for the items mentioned against each were evaluated by the Technical Committee, and other codal formalities were checked as per PPRA Rules. Details of the participating firms along with the quoted items is as under:-

- 7. After evaluation of the offers /bids submitted by the firms and scrutiny of documents, Technical Evaluation Reports were prepared and duly verified / signed by Technical Committee.
- 8. Total (05) firms i.e. M/s Adan Enterprises Nowshera, M/s Malik Enterprises Toba Tek Singh, M/s Chaudhary Enterprises, M/s Office Automations Multan and M/s Hashmi Trading Co participated in the tender for procurement of machinery & equipments. M/s Adan Enterprises Nowshera & M/s Malik Enterprises quoted for all items mentioned at Para-2/N, whereas M/s Hashmi Trading Co, Multan & M/s Office Automation Group, Lahore only quoted for the item mentioned at Sr.# 05 (Photocopier Machine) whereas M/s Chaudhary Enterprises, Lahore quoted for the item mentioned at Sr.#01 to Sr.# 04.
- 9. It is pertinent to mention here that **M/s Chadhary Enterprises** is **Technically Disqualified** for the quoted items as CDR is not attached along with the Technical bid as well as the firm has not provided samples within stipulated time. Moreover, the **"Toner Life"** of the item offered (Photocopier Machine) by M/s Malik Enterprises, Toba Tek Singh & M/s Office Automation Group Lahore is less (i.e. 23000 copies instead of 24000 copies). Both firms were contacted to provide clarification / justifications regarding above stated feature vide this office letter No. 263 & 264 dated: 20-07-2023 respectively. M/s Malik Enterprises, T.T Singh did not respond, however, M/s Office Automation Group, Lahore mentioned 3<sup>rd</sup> Party seller website links. The clarification provided by M/s Office Automation Group, Lahore is not acceptable by the committee on technical grounds. Hence, M/s Office Automation Group Lahore and M/s Malik Enterprises, Toba Tek Singh are **Technically Disqualified** by Sector Technical Committee for Photocopier Machine.

- recommends to open financial bids of **M/s Adan Enterprises**, **Nowshera** for all items at Sr # 01 to 06, **M/s Malik Enterprises Toba Tek Singh** for items at Sr # 01 to 04 & 06, and **M/s Hashmi Trading Co**, **Multan** for the item mentioned at Sr.05 (Photocopier Machine) mentioned at Para-02/N in the light of the term & conditions as laid down in the bidding document / PPRA Rules 2004.
