- 1. Meeting of the Procurement Committee-I (PC-I) comprising the members signed below, was held on 30th June, 2022 in the PTCL Building 3rd Floor, PTA HQ, F-5/1, Islamabad to evaluate the financial bid pertaining to the procurement of "Supply of Drinking Water Bottles to PTA HQ".
- 2. The Authority approved the Supply of Drinking Water Bottles (18.9 liters minimum) to PTA HQ.
- 3. The invitation to bid for advertisement was published in Urdu and English news papers and uploaded on PPRA /PTA websites on 20th April, 2022.

4. Technical Evaluation:

- i. Technical bids were opened on 17th May, 2022 by the Technical Evaluation Committee (TEC) in the presence of representative of bidder. TEC evaluated the technical bid of one (1) bidder as per criteria defined in the bidding documents. As per technical evaluation, Shan Marketing Services (distributor of Nestle Pakistan Ltd) was declared as technically qualified and recommended for opening of financial bid. Accordingly, the result of technical evaluation has been announced as per PP Rules 2004 on 17th June, 2022.
- ii. The Minutes of Meeting and technical evaluation sheet duly signed by the technical evaluation committee is attached as **Annexure** 'A'.

5. Financial Evaluation:

i. Financial bid of technically qualified bidder was opened on 29th June, 2022 in PTCL Building 3rd Floor, PTA HQ F-5/1, Islamabad at 1100 hours in presence of the representative of

the qualified bidder.
