CRITERIA FOR EVALUATION OF TECHNICAL PROPOSAL

1. General

The technical proposal of the Bidders shall be evaluated for qualification of bidders for the subject Bid based on the criteria regarding Eligibility, Work Experience, Equipment Capabilities and Financial Soundness as follows;

2. Weightage/Marks

The weightage/distribution of the marks shall be as given below:

i. Basic Eligibility (Mandatory)	35
ii. Experience of manufacturing of Steel/raw material	25
iii. Manufacturing equipment & Inspection / Testing Facility	20
iv. Financial Soundness	<u>20</u>

Total 100 Marks

The overall minimum qualifying score shall be 70% (35% from mandatory and 35% from others) marks to qualify. A detailed qualification criterion is given hereunder.

3. (i) Basic Eligibility (mandatory)

- f) The bidder must provide the information / detail on declaration beneficial owners information form as attached **(Annexure-C) (2 Marks)**
- g) In case of material to be imported, the bidder is to provide original proforma invoice of their principal abroad without showing the rates alongwith their technical bid. For bidders who are direct importer of the intended goods (HTS Wire 10mm dia from 16mm wire rod), they must provide the original proforma invoice of their principal abroad without showing rates alongwith their technical bid and proforma invoice showing rates alongwith their financial bid. **(2 Marks)**
- h) The bidder who is direct importer of the intended goods (HTS Wire 10mm dia from 16mm wire rod) must provide the authorization of their principal abroad / manufacturer. **(2 Marks)**
- i) The bidder must allow that the purchaser shall have the right of stage inspection of manufacturing facilities (If within Pakistan). The signatures of Bidders on all pages of bidding documents will be considered their permission. **(2 Marks)**
