2. In view of Technical Evaluation Report, Financial Opening Meeting was called of only those bidders who were technically qualified on 6<sup>th</sup> Aug, 2024. The Financial Evaluation minutes are (F/D). The rates given by the companies are as under:

3. Minimum 60% technical evaluation points were required for qualifying the technical bids. The technical and financial weightage was 60:40 respectively as per formula given below:

- v. Formula for Technical Evaluation (60%) = Marks Obtained/Total Marks x 60
- vi. Formula for Financial Evaluation (40%) = Lowest Rate/Quoted rates x 40

4. Detail of technical and Financial Scores obtained by the 03 companies is as under:


