### NAME OF WORK: RE-HABILITATION OF ROUND ABOUT OUTSIDE KHAMIS GATE AREA EAST WHARF.

#### **INTRODUCTION:**

1.AXEN (KW) vide his letter placed at S.No.1 has informed that, the Chief Engineer KPT visited the East Wharf Area. During the visit the Chief Engineer shown his concern, as the hindrance in the smooth flow of traffic leading towards Port Area East Wharf, due to dilapidated condition of round about and access ways outside Khamis Gate East Wharf. Photographs showing the deteriorated condition of round about surrounding roads placed at 1/C. The Chief Engineer directed to take up the matter on top priority.

Keeping in view the dilapidated condition of road. Accordingly, AXEN (KW) surveyed the site and in-order to resolve the issue prepared an Estimate amounting to Rs. 9,394,707.00 alongwith a Plan placed at S.No. 1/A & 1/B respectively for attending the work, as the same is beyond the scope of KPT's In-house arrangements.

2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through Press, KPT / MoMA & PPRA Website on 02-05-2023 and received on 22-05-2023.
