INTRODUCTION:

1. The Oil Pier-III is utilized for import of various commodities like POL & Non POL, Nephthat, Molasses etc for all over the Country, hence same plays very important role in Port Operation and life line for the economy of country. AXEN (KW) has carried out the survey and has observed that the condition of existing M.S Railings of walkways is in dilapidated condition. Furthermore various other allied maintenance works are required to be attended in order to keep the subject Oil Pier in operational state and presentable condition. (Photograph placed at S. No.1)

Accordingly, AXEN (KW) prepared an Estimate amounting to Rs.7,903,574.00 alongwith Plan placed at S.No. 2/A & 2/B respectively, to attend the work through outsource, as the same is beyond the capacity of KPT's In-house arrangements.

- 2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through Press on 13-04-2023 & KPT / MoMA & PPRA Website on 15-04-2023 and received on 02-05-2023.
- 3. In response following Two (02) Firms submitted their sealed Technical & Financial Proposals 02-05-2023 as per the Advertisement.

Keeping in view the deteriorated condition of OP-III it has been assessed the subject work is very much necessary to be undertaken in-order to avoid any fatal incident and to fulfill the National Requirement of POL, otherwise unrecoverable loss of infrastructure is most expected to be occurred.

Hence, the Technical & Financial Evaluation Committee after due diligence has recommended the Lowest Evaluated Bidder has stood Qualified, after the due scrutiny of the Technical & Financial Proposals, the details mentioned as under:

In light of the above, the In-house Committee recommends to the Departmental Tender Committee for awarding the Contract to the Lowest Evaluated Bidder amounting to Rs.10,048,468.50 (Rupees: Ten Million Forty Eight Thousand Four Hundred Sixty Eight & Fifty Paisa Only) received from M/s. Al-Madad Construction Co. which is about 27.13% above the corresponding estimated cost of Rs.7,903,574.00 based on KPT draft amended schedule of rates (2002) 2013 and as per current market rates is considered reasonable and recommended for the award of the contract, as the same seems viable due to the economic un-certainty and surge in inflation across all over the country.
