**MINUTES OF THE MEETING OF THE DEPARTMENTAL TENDER COMMITTEE HELD
ON 08-05-2023 IN THE COMMITTEE ROOM OF ENGINEERING DEPARTMENT KPT.**

INTRODUCTION:

The residents of KPT Flats No. EK-(29, 49, 50, 51, 52, 56, 58, 59, 63, 64, 67, 81, 82, 86, 89, 110, 131 & 132) at Keamari Village vide their application placed at S.No.1, have requested for the maintenance of their flats which are in much deteriorated state & requires necessary repair/ maintenance, in-order to keep these KPT assets in shipshape order also to enhance their useful life.

Therefore AXEN (KV) as per the requirement surveyed the quarters and prepared an Estimate to attend the work through outsourcing, as the work is beyond the capacity of KPT's In house arrangements.

Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through Press, KPT, MoMA & PPRA Websites and received on 19-04-2023.



RECOMMENDATIONS:-

1. Tenders for the work were invited on 19-04-2023, and the Lowest Evaluated Bid amounting Rs. 14,258,419.67 (Rupees: Fourteen Million Two Hundred Fifty Eight Thousand Four Hundred Nineteen & Sixty Seven Paise Only) received from M/s. Allah Bux Kalwar, which was about 09.92% below the corresponding Engineer's Estimated Cost of Rs.15,829,215, after evaluation it appears to be non responsive, as the bidder was failed to fulfill the mandatory requirement under Clause 2 (f) as published in Advertisement.
 - In case of companies and firms, last three years Audited Financial Statements are to be provided showing minimum average turnover of Rs. 15.0 (M).
 - In case of individuals / sole proprietors, last three years tax returns filed with FBR are to provided showing minimum turnover of Rs. 15.0 (M) on average for three years.
2. The firm M/s. Allah Bux Kalwar submitted the last three years Audited Financial Statement showing the work of Company Rs. 8.2 (M) instead of Rs. 15.0 (M), hence considered non-responsive.
3. Further, the Committee observed that, the offer of the 2nd Lowest Responsive Bid received from M/s. Friends Construction Syndicate (Pvt.) Ltd. is Rs.15,492,544.58 (Rupees: Fifteen Million Four Hundred Ninety Two Thousand Five Hundred Forty Four & Fifty Eight Paise Only) is about 2.12% below, the corresponding estimated cost of Rs.15,829,215 (Rupees: Fifteen Million Eight Hundred Twenty Nine Thousand Two Hundred Fifteen & Fifteen Paise Only) & there is difference of only 7.82% than the non-responsive Bidder M/s. Allah Bux Kalwar.
4. Hence, the offer of Lowest Responsive Bidder, M/s. Friends Construction Syndicate (Pvt.) Ltd, may be considered for the wok, as M/s. Friends Construction Syndicate (Pvt.) Ltd, has offered a very meager difference of Rs.1,234,125.00 as compared to the Non Responsive Bidder & re-inviting of fresh Tenders may lead to waste of precious time and there is very much chance of receiving higher rates / bids as per the current price inflation in the market rates.
5. Therefore, considering the position as explained in the foregoing para, the Committee is of the opinion to accept the offer of the Second Responsive Evaluated Bidder amounting to Rs.15,492,544.58 (Rupees: Fifteen Million Four Hundred Ninety Two Thousand Five Hundred Forty Four & Fifty Eight Paise Only) received from M/s. Friends Construction Syndicate (Pvt.) Ltd., for this work.
