## SUB: AWARD OF WORK FOR APPOINTMENT OF CONSULTANT FOR TOP AND SITE SUPERVISION SERVICES FOR RECONSTRUCTION OF BOAT BASIN JETTY PHASE-H, KEAMÄRI.

In house P&D's Engineers Committee comprising of Mr. Naushad Anwar AXEN, Mr. Arif Badar Ansari XEN and Syed Zahid Hussain PM(P) vide their report dated 03-08-2021 had recommended to the Departmental Tender Committee as under:

"Award of Work to the consultant M/s Zaheeruddin Consultant at their Bid amount Rs.40,414,415.87 (Rupees Forty Million Four Hundred Fourteen Thousand Four Hundred Fifteen Rupees and Eighty Seven Paisa Only) (including WHT & SRBs(SST) which will be charged as per prevailing FBR Rules."

DTC members including General Manager (P&D), General Manager (Ops), General Manager (Admn), General Manager (Civil Work), General Manager (RED) and General Manager (Engg.) reviewed the recommendations of P&D in house Engineers Committee and endorsed their technical and financial report, However, General Manager (Finance) did not sign the DTC Report and had raised the query and recommended in order to materialize the case, the following committee may also evaluate the aspects of financial bids including arithmetic accuracy and put up the case before GM's Committee at the earliest:

- The above Committee after deliberations and discussions concluded in their report that the figures as illustrated in para 5 table are correct. However, in order to address the query raised by GM (F) which requires the clarification from M/s Zaheeruddin Consultants (Pvt.) Ltd. that no mobilization advance against Insurance Guarantee and provision of vehicles will be granted.
- 4. Accordingly, Executive Engineer (P) asked M/s Zaheeruddin Consultant Pvt. Ltd. to clarify the matter. In response M/s Zaheeruddin Consultant vide their letter dated 12-08-2021 responded as under:

"After review our financial proposal we would like to confirm that we are unconditionally withdrawing our assumptions stated in Financial Proposal clause 1.5 and 1.6."
