M/s Miraj Innovative Solutions (Pvt) Ltd quoted lowest rate in principal however the minimum wages rate per janitor after tax deduction does not according to approved minimum wages rate by Govt of Punjab / Pakistan. Undertaking provided by the bidder (M/s Miraj Innovative) contradicts with the labor laws rules in this regard & tender term # 2.4 & 13.3 clause Eligible Bidders and adhere of Govt labor laws respectively, which clarified by M/s Miraj Innovative Solutions (Pvt) Ltd. In reply M/s Miraj Innovative Solutions negated his own quotation through his reply which contents on daily wages basis while submitted quotation particulars are on monthly basis as per tender contents. M/s Miraj Innovative Solutions(Pvt) Ltd reply considered unsatisfactory by ZPC members and quotation rejected subsequently. further quotation of M/s Imran & Co (Sambaryal) is recommended as 2nd lowest in the light of Govt Labor Lawas & Regulations
