The bidder(s) must provide copies of contracts, work orders, supply orders etc to establish and substantiate the required experience. 3) Bidder must provide Purchase Orders/Completion Certificates/Contracts of 03 references from clients for verification of the successful completion. 4) The Bidder must have verifiable presence/support/branch office in Islamabad/Rawalpindi to provide support. 5) The Bidder must have Technical strength of at least 03 (Three) certified resources. 6) Bidder(s) shall provide NTN & STRN Certificates along with its active status on ATL of FBR. 7) The bid forms and price schedule should be submitted on the prescribed format on company's letterhead. 
