INTRODUCTION:

1. KPT Petrol pump at West Wharf provides petrol to all the official vehicles, due to lengthy lines it becomes inconvenient for the staff to work as there is no protection from sunlight, therefore fiber shed on the pump has been proposed.

Accordingly, AXEN (MIY) after visiting the site has prepared a Plan & an Estimate amounting to Rs.932,589.00 for attending the work, as the work is beyond the capacity of KPT In-house arrangement.

2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 29-07-2024.

RECOMMENDATIONS

The Single Evaluated Bid amounting to Rs.999,948.86 (Rupees: Nine Hundred Ninety Nine Thousand Nine Hundred Forty Eight & Eighty Six Paisa Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. SAK Contractors which is 07.22% above the corresponding estimated cost of Rs.932,589.00 based on market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. SAK Contractors is considered capable for carrying out the work viz. “CONSTRUCITON OF NEW FIBER SHED AT PETROL PUMP M.I YARD WEST WHARF”.

The Committee therefore, recommends the acceptance of the Single Evaluated Bid amounting to Rs.999,948.86 (Rupees: Nine Hundred Ninety Nine Thousand Nine Hundred Forty Eight & Eighty Six Paisa Only) received from M/s.
