- i. M/s Paper Line, Islamabad
- ii. M/s ASM Enterprises, Islamabad
- iii. M/s Casio Centre, Islamabad
- 12. Any other additional / supporting information, the procuring agency may like to share.
- 13. It was further observed by the committee that rates were also solicited from the bidders for refill of Toners besides purchase of new Toners/Cartridges. However, M/s Casio Center has quoted the rates for refill of Toners for all categories whereas M/s ASM Enterprises has quoted rates for refill for only three categories of Toners / Cartridges. Other firm have quoted rates for new Toners / Cartridges only. The Committee observed that rates for Refill of Toners/Cartridges, as quoted by M/s Casio Centre Rawalpindi in respect of most of Toners/Cartridges were higher than the lowest quoted rates for new Toners/Catridges. Therefore; keeping in view the transparency, value for money as well as due to low competition in the Category of Refill of Toners/Cartridges; the Committee unanimously recommended to reject the financial proposals for Refill of Toners/Cartridges.
