In pursuance of PSB office order No.F.41-2/2023-PSB (Admn) dated 18th June, 2023, a Technical & Finance Committee was constituted to open the bids stitching of uniform items for Pakistan Contingent participating in the mega sports events. A copy of the office order is enclosed at **Annex-"A"**.

2. Pakistan Sports Board (PSB) floated tender in the newspapers to obtain competitive rates from the firms registered with NTN & Sales Tax Departments stitching of uniform items for Pakistan Contingent participating in the mega sports events. The tender notice was published on 5th August, 2023 in the "Daily Dawn, Daily Dunya and Daily Ausaf, Islamabad" as well as uploaded on PPRA website. Copies of the press clipping are enclosed at **Annex-"B"**. The offers were required to be submitted by the bidders under single stage two envelopes procedure containing **Technical and Financial Bids** in separate sealed envelopes. The last date for submission of the bids was 21st August, 2023 at 1130 hours.






3. A statement of rates offered by the M/s Swift Enterprises, Islamabad only technically qualified bidder is enclosed at **Flag-C**.


