INTRODUCTION

- Karachi Port Trust, Engineering Department has its own schedule of rates for carrying out Civil Works
 through Engineering Contracts. First time rates were prepared in 1985 and updated in the year 1991.
 However, in order to revise the Schedule Rates KPT Board vide BR No. 256 dtd. 04-02-2003 approved the
 new Rates for Civil Engineering Contracts.
- 2. Due to change in Currency Rates (i.e. Dollar) Market inflation in Building material and Labor charges, the market has tremendously changed and has increased to the extent that schedule of Rate of 2002 has become outdated, with the result that this division is facing immense difficulty to get realistic Estimated Costs and prices of Civil Engineering Works.
- 3. As of today the adopted Schedule Rates are more than 18 years old, due to such this division is receiving tenders amounting more than plan & estimate which are being prepared on basis old schedule rates dor schedule items. Keeping in view this Department invited tenders from consulting firsm / individual for revising the rates of all items for Buildings, Roads, Sanitations, Water Supply and Railways etc to get and prepare competitive cost estimate and tenders as per prevailing market rates.
- 4. Bids for the work were therefore, invited under Clause 36 (a) of PPRA Rules-2020 from Consultnats through KPT, MoMA & PPRA Websites and were received on 18-07-2022.
