10. Details of Bid(s) Evaluation: All three bids were technically evaluated. 02 bids did not meet mandatory criteria as prescribed in ToR's published and hence were not further evaluated. Only one bid qualified against specified mandatory criteria and its technical and financial bids were evaluated accordingly and M/s A.F. Ferguson & Co Consortium secured 83.4 marks out of 100 in technical evaluation and 20 out of 20 marks in financial bid evaluation. As per prescribed scoring weightage criteria, evaluation summary is as follows;
