THE BOARD OF PUBLIC PRIVATE PARTNERSHIP AUTHORITY (P3A) INVITES APPLICATIONS
FOR THE APPOINTMENT OF CHIEF EXECUTIVE OFFICER P3A

In accordance with its statutory mandate under the Public Private Partnership Act, 2017, as amended (the “P3A Act”), the P3A Board is inviting applications from qualified, experienced, and motivated professionals for the purpose of making recommendations to the Federal Government for the post of Chief Executive Officer (CEO) of the P3A.

Public Private Partnership Authority (“P3A”) is an independent body corporate established under the P3A Act. P3A has been established in order to create an enabling environment for development projects and the provision of public infrastructure and related services in Pakistan through private sector participation.

The eligibility criteria include:

- i. Post-graduate degree (Masters or equivalent) in one of the following subjects i.e. finance / public administration / business administration / engineering from a local or foreign institution recognized by the Higher Education Commission (HEC); graduates from top-ranked global universities/institutions will be given preference.
- ii. At least 15 years of professional work experience (post undergraduate degree) in local/international public or private sector organizations with at least 5 years in a senior management/executive role; experience leading an organization is a plus.
- iii. Deep knowledge and expertise of local/international public policy, development financing and structuring of complex development projects on public private partnership basis is a must.
- iv. Experience of engagement with stakeholders across the Federal and Provincial Governments, and experience of successfully working on transactions in emerging markets is a must.
- v. Ability to build credibility and reinforce trust in the new PSDP+/PPP model; experience working in partnership with international development institutions is a plus.
- vi. Strong understanding and track record of leading innovative programs and initiatives, with an ability to inspire confidence and deliver while working with a diverse set of stakeholders under tight timelines and with limited resources.
- vii. Track record of sound professional judgment, integrity and proven skills in organizational design, development and leadership; knowledge of corporate governance and experience of serving on Boards is a plus.
- viii. Commitment to the mission of the P3A and the Ministry of Planning, Development and Special Initiatives.
- ix. Minimum 40 years of age.

Market based salary and allowance package will be offered to the selected candidate. Interested candidates are required to submit their **CV/Resume** within fifteen (15) days of the publication of this advertisement. Incomplete applications will not be accepted.
