
TERMS AND CONDITIONS

2. Having understanding of International Law and skills of rendering legal opinions on policy and regulatory matters concerning International Law, preferably International Investment Law or Trade Law.
3. Excellent communication and interpersonal skills and ability to communicate effectively at national and international forum.
4. Commitment to professionalism, discipline and integrity.
5. Strong leadership skills and an ability to work effectively in a team.
6. Preference to be given to those with a Master or specialization in International Investment Law for the position of MP-III Scale.

CONDITIONS TO APPLY

Applicants should submit their applications on the prescribed format along with CVs and attested copies of relevant certificates and documents, within fifteen (15) days of publication of the advertisement at the address given below. 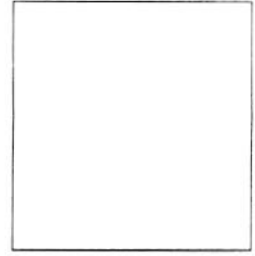
