Pakistan Airports Authority invites bids from reputed Medical Healthcare Service provider firms, registered with Pakistan Medical Commission (PMC) / Provincial Healthcare Commission, Income Tax and Sales Tax Departments and on Active Taxpayer List of FBR, in accordance with PPRA Rule No.36(b) for provision of Nursing and Paramedical Staff at PAA Airports / Locations for an initial period of 02 years (extendable for another 06 months on mutual consent and satisfactory performance by the firm).
