2. Bid documents, containing method of procurement (single stage single envelope procedure), detailed terms and conditions etc are available on PPRA-EPAD System (<https://eprocure.gov.pk>).

3. To participate in the tender process, bidders must be registered with the Federal Board of Revenue (FBR) and listed on the Active Taxpayer List (ATL). They must possess a valid National Tax Number (NTN) Certificate, a Professional Tax Certificate, and updated Pakistan Engineering Council (PEC) registration in Category C-6 or above for the current year, with specialized codes CE-01, and CE-10. Additionally, bidders must have relevant experience and submit their Computerized National Identity Card (CNIC) along with affidavits confirming ownership, no blacklisting, and no litigation at the time of tender submission. Sealed tenders containing all required documents must be submitted within the specified deadline.

4. The bids must be submitted electronically through the PPRA EPADS Web Portal (<https://eprocure.gov.pk>) before the closing date and time. Bidders are also required to submit hard copies of the bids on the due date and time at the office of the Sr. Joint Director, ES Civil Task Force, JIAP, along with the original bid security in the form of a pay order or bank draft from any scheduled bank, drawn in favor of "CAA Works Unit, Makran Coastal Area." The bids should be submitted in a sealed envelope, and a copy of the same must be uploaded on the EPADS online portal.

5. PAA reserves all rights to accept or reject any or all the tenders for sufficient and cogent reasons which will be communicated to the bidder on request.
