INVITATION FOR BIDS THROUGH EPADS

1. Bid Identification No. 398-Sig/SUP/KYC/Tender/2024-2025. Pakistan Railways (PR) acting through the Project Director/Signal Up-gradation Project (the "Employer") has planned to execute the project "**Up-gradation of the Signaling System by providing Computer-Based Interlocking at Jumma Goth, Badal Nala & Landhi stations**".
2. Project Director/Up-gradation Project (The Employer) intends to invite electronic bids (Technical & Financial Proposals) through E-Pak Acquisition and Disposal system (EPADS) link (www.eprocure.gov.pk) from eligible firms / bidders (Joint Venture of firms or local Subsidiary body of Foreign Firm) on the basis of Single Stage - Two envelop bidding procedure as per PPRA rules. No bid other than EPADS will be accepted.
3. Bidding documents, containing detailed terms and conditions, can be downloaded from <https://eprocure.gov.pk> free of cost.
4. The bids prepared in accordance with the instructions in the bidding documents, must be submitted on EPADS as per the schedule time mentioned below. Bids submitted late will be rejected.
5. A foreign firm/bidder is eligible to participate either as part of a joint venture with other firms or as a local subsidiary body of a foreign firm.
6. A local bidder/firm must be registered with the Pakistan Engineering Council (PEC) in Category C1 or higher. In the case of a local subsidiary body of a foreign firm, the firm must provide the PEC certificate for the C1 category or above at the time of the contract agreement.
7. The Bidder will also upload/submit their electronic Bid (the complete scanned copy of their bid) on EPADS. **Note: EPADS Tender No. F-250191199.**
8. The Bidder must submit Bid Security/Earnest Money amounting **Rs. 20.000 million**. The Bid Security can be in the shape of Call Deposit Receipt (CDR) / Banker's Cheque or Bank Guarantee (in favour of FA&CAO, PR) in accordance with form, provided in the Bidding Documents. The CDR or Bank Guarantee should be issued by any schedule bank in Pakistan. However, in case it is issued by a foreign bank then it must be duly counter guaranteed by a Scheduled Bank in Pakistan. The Bid Security must be submitted / delivered before closing date & time of the tender to the Office of the Project Director/Signal Up-gradation Project Headquarter, Empress Road, Lahore, Pakistan and the soft copy of CDR or Bank guarantee should be uploaded on EPADS link.

Bids must be submitted on EPADS at **13:30 hrs** or before on **19th February, 2025**, whereas Bid security in original shall be submitted at **14:00 hrs** or before on **19th February, 2025** in the office of Project Director/Signal Up-gradation Project, Pakistan Railways Headquarter office, Lahore along with other necessary documents as stated in bidding documents. Bids will be opened at **14:00 hrs** on the same day in the presence of bidders or their representatives who choose to attend at the same address.
