 - Only Bid through E-Pak Acquisition and Disposal System (EPADS) will be entertained (www.eprocure.gov.pk). No bid other than EPADS will be accepted.
 - The Bidders should deposit 2% Earnest Money of the quoted amount in the shape of Bank Draft from any Scheduled Bank in favor of Divisional Accounts Officer, Pakistan Railway Lahore, Division and submit CDR before closing date of tender **18.02.2025** physically and attach it with Tender box in the office of DAO PR Lahore. Bid will be opened on the same date **18.02.2025 at 12:30 hours**. The name of firm/agency on the CDR is mandatory.
 - Bidder will upload the complete scanned copy of their bid in EPADS. Note EPADS Tender No. **F-250191868**.
 - The Bidding documents containing detail terms and conditions, can be downloaded from (www.eprocure.gov.pk) free of cost. This advertisement is also available on PPRA, Railway Website and EPADS website.
 - The bids prepared in accordance with the instructions in the bidding documents must submit on EPADS as per schedule.
 - The overall approximate cost of the tender items comes to **Rs.5.998 million**.
 - The Tender will be opened in the presence of Tenders and Tender Committee members on the same date **at 12:30 hrs.**
 - Bidding will be conducted using National competitive bidding procedures as specified in the Public Procurement Regulatory Authority (PPRA-2004-08).
 - The Bidder, who is on **Active Taxpayer's List (ATL) of FBR** will be eligible to participate in the tender.
 - Conditional, incomplete tender without 2% Earnest Money and Bidder(s) not fulfilling the above mentioned requirements shall be considered as non-responsive and shall stands disqualified i.e. Bidder(s).
 - The rules quoted should be valid for a period of 30 days after the bid opening date. The successful Bidder shall give performance guarantee @ 10% of the contract amount.
 - The Bidders shall provide the samples of each item/article at the time of opening tender; otherwise offer will be rejected by the Tender Committee. Specification of items will be given to the firm on contacting within schedule time of tender.
